\*The processing time (# of business days) is a good faith estimate and may change depending on the volume of work received at our offices and the resources available at the County (if required), Secretary of State, and the U.S. Department of State offices. The number of business days does not take into consideration the FedEx/UPS shipping to and from the government office and the FedEx/UPS shipping back to your return address. We recommend that you do not book any appointments or make any reservations until your documents have been completed and delivered back to your return address. Orders over \$500 will require a signature upon delivery. Please expect additional delays during the summer season (June through September) and during the Holiday season (November through January). FedEx/UPS interoffice shipping fee is \$45. FedEx/UPS international priority shipping fee is \$100 to most countries. Please review and accept the Terms and Conditions listed on our website. \*\*The County Clerk authentication processing time is estimated and in addition to the processing time of the State. Some types of documents will require County Clerk authentication before the state will attach the apostille. Please contact us for the most up-to-date estimated processing time and availability before sending in your documents.

Notarized Documents: Documents improperly notarized and returned by the State or County are immediately assessed a \$125 non-refundable fee. If your documents require notarization, please be sure to find an experienced notary public with a minimum of 5 years of service. The notary must include the venue (State and County) including the jurat/acknowledgment statement. All signatures must be original. The notary can reference their notary handbook provided by the state for further instructions. If the notary makes a mistake, your documents will be rejected, and you will have to start over costing you time and money.

<u>Volume Discount Fee</u>: Our volume discount fee for each apostille applies to 15+ documents mailed in at the same time, for the same country, and originating from the same state. Certain restrictions apply. Please contact us for details.
